To be valid the Form of Proxy, together with the power of attorney or other authority (if any) under which it is signed or notarially certified or office copy of the same, must be delivered to the offices of Link Asset Services, Shareholder Services, PXS1 The Registry, 34 Beckenham Road, Beckenham, BR3 4ZF (Re: ReneSola AGM 2019). by no later than 48 hours before the time fixed for the meeting or any adjourned meeting (excluding Saturday, Sunday and public holidays in United Kingdom and China).
5. Any alterations made to the Form of Proxy should be initialled.
6. In the case of a corporation the Form of Proxy should be given under its Common Seal or under the hand of an officer or attorney duly authorised in writing.

Registered holders of American Depositary Shares at close of business on November 12, 2019 (New York Time) will receive a Depositary Receipt Voting Instruction Card for this purpose and the Depositary Receipt Voting Instruction Card must be completed, signed and returned on or prior to December 9, 2019 at 5:00 p.m. (New York Time). Pursuant to Regulation 7.4 of the articles of association of the Company, the Board has determined that only those members registered in the relevant register of members of the Company at close of business on November 12, 2019 shall be entitled to attend and vote at the shareholders meeting or, if the meeting is adjourned, close of business on such date being not more than two days prior to the date fixed for the adjourned meeting. Changes to entries in the register of members after close of business on November 12, 2019 shall be disregarded in determining the right of any person to attend or vote at the meeting.
